Get Involved With Wellhead Protection!

Ground water often moves very slowly. Once it is contaminated, it may remain so for a long time, and it is difficult and expensive to locate and remove the contamination. It may require decades of treatment before the water is restored to drinking water quality. In some cases, the contamination may never be completely removed.

If you get your water from a well that supplies water to more than 15 connections, your water supplier will, in the near future, be putting together a "plan" to prevent contamination of the water you drink. This plan is called "Wellhead Protection."

Every well is different in degree of contamination risk. If there is a protective layer of soil or rock between the surface and the aguifer from which your water is drawn, there is a better chance there will be no contamination in the aguifer. Even if a good, protective confining layer exists, contamination can occur if there are "leaks" in the layer. Leaks may be in the form of rock crevices or improperly constructed wells. Water also moves naturally, although very slowly, down through the confining layers. Therefore, contaminants should be dealt with at the surface so they don't have a chance to enter your drinking water supply.

If everyone becomes aware of contaminants and deals with them properly, our water can remain drinkable for years to come. Here are a few things you can do to help keep hazardous wastes out of our aquifers:

- Read product labels to identify what is hazardous
- Purchase fewer hazardous materials, choose the least toxic product, and consider changing business/household practices to avoid producing hazardous wastes
- Reduce, reuse, and recycle garbage and hazardous wastes
- Manage hazardous wastes responsibly—use, store, and dispose of properly

This article is part of a series of articles related to wellhead protection. The goal of wellhead protection is to prevent pollutants from contaminating public water supply wells. Our city has developed a wellhead protection plan which will only be effective if the community is involved. Truth - in Taxation Hearing

The Truth-in-Taxation Hearing on the proposed 2018 Budget and Property Tax Levy is scheduled for 6 p.m., Tuesday, December 12th, 2017 in City Hall's Council Chambers. The general public is encouraged to attend.

Why do my property taxes change every year?

The State of Minnesota has a complex system for calculating property tax, and the amount of tax assessed to a property changes from year to year based upon a number of factors. The decisions made by the City Council, County Board and School Board about the amount of tax dollars needed to deliver services may be the most obvious factors affecting property tax bills. Other factors that impact property tax bills include the value of the individual property, the total value of properties in our community, changes in state programs and changes in state laws that affect the tax system.

How does the city calculate the property tax levy?

The City of Rockford's budget process is a year-round project that begins to take shape in the summer months each year. The prior year's budget is compared to the revenues and expenses received to date and projections are made and revised for the following year until the preliminary budget and preliminary property tax levy is established. To calculate the preliminary property tax levy, the city reviews available revenues and compares those with the projected expenses for municipal operations for the following year. These expenses usually exceed projected revenues, so the difference between these numbers is the amount of revenue the city needs to raise through taxation to balance the city's budget. Cities are required by Minnesota Statute to certify a proposed levy amount to the County Auditor no later than September 30th of each year. Cities are able to decrease the amount of the property tax levy, but generally cannot increase the levy amount after it is certified. The city carefully compares revenues and expenses from September through December to establish the Final Property Tax Levy. This final levy is what is collected as property tax for the following year.

Long Term Debt

One of the biggest factors impacting the 2018 Property Tax Levy is the city's amount and duration of long term debt. As shown in the chart below, the city has four outstanding bonds that are funded by levied property taxes. The city recently sold the Rockford Mall (Bond 2014A) for just over \$1.45 Million. That revenue, along with the sale of the lot to Dollar General and the anticipated TIF Increment, will allow the City to pay off this bond debt and proportionately reduce the overall Debt Service property tax levy.



2018 Budget and Property Tax Levy

The City of Rockford established a 2017 General Fund and Debt Service Budget last December with expenses totaling \$2,380,604. The city levied \$1,310,115 for operating expenses to provide city services, and \$307,138 to pay the city's long term bond debt. The 2018 Proposed General Fund and Debt Service Budget is currently set at \$2,471,488. The proposed levy for operating expenses is set at \$1,331,025, which represents a increase in operating expenses of \$20,910; or 1.59%. The city's long term debt levy is set at \$307,649 based upon the principal and interest payments due and payable in 2018. These debt service payments represent an increase of \$511 from the 2017 amount of \$307,138; or .16%. Based upon these figures, the city's total 2018 Property Tax Levy is currently recommended to be \$1,638,674; which represents an increase of \$21,421 from the 2017 Property Tax Levy of \$1,617,253; reflecting an overall increase in property taxes of 1.32%.




2018 Projected Revenues

The pie chart featured to the left highlights the general categories of revenues received by the city that support city services and operations. Property taxes and Local Government Aid funding provides the majority of city revenues. Other sources of revenue that support city operations include revenues generated from permits and fees, interest income from the city's investments, transfers, and a variety of small miscellaneous sources.

2018 Projected Expenses

The pie chart featured to the right highlights the general categories of expenses involved in city operations and providing city services. The Public Safety category includes the Fire Department and what we pay for police services from the County Sheriff. General Administration includes all expenses and materials costs that are involved in administrative operations. Public Works includes all equipment, maintenance and materials used in their operations. Planning, Zoning and Transfers includes expenses involved in city planning and funding to support services in other funds, and Parks and Recreation covers the cost of maintenance operations for our city parks and the library.





The chart to the right shows the city's long term bond debt over the same time frame. The city has paid off or refinanced existing bond debt to stabalize and reduce the amount of long term debt impacting city property taxes. Long term debt and operations costs are factored to stabalize the city's tax levy.



The following charts track the city's property tax levies over the past several years. The chart on the left shows the operations tax levy which funds city services. The City Council and Staff have worked hard to control the operation costs and increase available revenues in city operations to reduce the tax impact on properties in Rockford.



This chart to the left shows the total property tax levy for the City of Rockford over the past five years. It should be noted that the 2018 Levy is preliminary and cannot be increased at the Truth in Taxation meeting. It will be important to focus on reducing long term debt and operations costs carried by the city to control property tax increases in future years.

Wastewater Billing Calculation (Actual vs. Averaging) Open Until the end of December 2017

Historically wastewater rates had only been calculated based on the average water used between November 15th and April 15th and recalculated annually. In 2014 the City Council passed an ordinance to allow residents the choice between being billed for their wastewater use based upon their actual water use or continuing with the old system which averaged winter water use and billed that average as the wastewater usage over the summer months.

All residents in Rockford are assigned the averaging billing system for wastewater unless you have requested to be on actual use. You must contact City Hall between **December 1st and December 29th**, if you wish to change your billing system for it to be effective for the January 2018 billing. Annually, December is the only time you can change your wastewater billing calculation and can do so by calling **City Hall at 763-477-6565 (press 1)**.

WINTER SEASON INFORMATION

Snow Season Parking

The snow season ordinance is in effect November 1st until April 1st and it shall be unlawful for any person to park a vehicle on or within six feet of the roadway between 2am-6am OR after ice accumulation, continuous or intermittent snow fall during which there has been an accumulation of two inches or more of snow on any street until the same has been plowed or removed from the full width of the roadway. On street parking is prohibited from 4am-6am on ALL non-residential streets regardless of snow. At NO TIME shall a vehicle be parked upon ANY street in any one place for more than twelve (12) hours. Please make sure that your guests are aware of these regulations so that they don't end up with a ticket or worse yet, getting towed.

Maintain a safe driving distance behind snow plows.

Sidewalk Snow Removal

In the interest of public safety, the City of Rockford reminds you of the importance of keeping your walkways cleared of snow and ice. City Ordinance 901.04 states that all snow and ice must be removed from public sidewalks 24 hours after the snow or other precipitation causing the condition.

If you live near a fire hydrant, please keep it clear of snow and ice.

Snow Plowing

It is unlawful to plow snow onto ANY city, township, county or state road. Doing so is a violation of Minnesota Statue 160 and

Snowmobiling

Persons operating snowmobiles within the city limits **must travel on designated trails**. Snowmobiles are prohibited from any public sidewalk/trail ways provided for pedestrian travel, on private property without the owner's permission, and all other public property unless designated as the snowmobile trail. There is no parking or riding of snowmobiles on the levee or in city parks, per Ordinance 208.
