The meeting was called to Order by Mayor Renee Hafften at approximately 5:00 p.m. Council Members Debbie Buoy, Jeannette Graner, Ted Hill and Rick Martinson were also present.

City Administrator / Special Counsel, Dan Madsen; City Engineer Jared Ward, Wenck and Associates; and Megan Carr of Sand Companies were also in attendance.

Megan Carr presented a proposal for a workforce apartment complex consisting of approximately 40 units for three separate locations in Rockford. Members of the Council heard and discussed the company, general ideas regarding the housing project and what contribution would be required from the City of Rockford. The Council asked Ms. Carr to return to the May 9th, 2017 Council Meeting to more formally discuss the proposed development. No action was taken on this item as it was set on for informational purposes only.

City Administrator / Special Counsel, Dan Madsen; City Engineer Jared Ward, Wenck and Associates; members of the Wright County Assessor's Office; Captains and Lieutenants of the Wright County Sheriff's Office; and, John Quirk, Street Superintendent were also in attendance.

Public Hearing, Reconvene Local Board of Appeal and Equalization

Mayor Renee Hafften opened the Public Hearing at approximately 6:05 p.m. Members of the Wright County Assessor's Office presented information on the continuation of the appeal of the property owner of PID #:113.021.001.060. The Assessor reviewed the nature and amount of damage to the interior of the home, and stated that the County and resident agreed to a reduction in the assessed market value of the property as presented. Members of the Council and staff asked questions regarding the decrease in valuation, stating some concern that the lack of care of a property owner would be

cause for reduction in market value; in effect having the other members of the community pay part of the taxes of a negligent homeowner. After discussion and review, Mayor Hafften opened the floor to any members of the public for comment, discussion, consideration and review. With no one wishing to make comment or otherwise address the Council, **MOTION** was made by Martinson, and seconded by Hill, to approve and otherwise accept the new valuation as presented and recommended.

New Business: Rockford Area Historical Society Quarterly Update

Dustin Bardon of the Rockford Area Historical Society reviewed activity of their organization over the past quarter and discussed current initiatives and upcoming

plans for their group. Additionally, Bardon provided information on recent and future initiatives and plans the group hopes to continue. Members of Staff and the Council asked questions and had general discussion. No formal action was taken, as this was for informational and introductory purposes only.

New Business: Resolution #17-18/Award 2017 Seal Coat Project Bid.

Street Superintendent John Quirk explained that the City had received two estimates for the City's 2017 seal coating projects. Quirk read both quotes, and explained that the quote from Pearson Brothers was the lower of the two quotes. Quirk also added that the quote from Pearson Brothers was under the city's planned and budgeted amount. After additional discussion and review, **MOTION** was made by Hafften, and seconded by Graner, to approve Resolution #17-18 to award the bid in an amount not to exceed the listed and quoted amount.
