MAYOR'S MESSAGE

The City Council reviewed a 20 year Capital Improvement Plan to maintain our streets and utilities. This plan is in place to ensure costs are spread over a period of time to avoid large debt all at once. I want to thank everyone who attended the November 5th Open House and November 12th Public Hearing from Maplewood Manor on the 2014 portion of the plan. Based on the feedback we received from residents the decision was made to NOT complete the street improvements at this time. Therefore, residents will not be assessed for a 2014 street improvement.

We will still be moving forward with

the water and sewer improvements. During the replacement of the water and sewer mains, the council is also planning to inspect all the sewer lines coming in from each house to determine if there are problems which need to be addressed. For example, our sewplant is processing over er 300,000 gallons a day, but we are only charging for 200,000 gallons. This is due to water infiltrating our system from cracks in the pipes. When 50 year old pipes decay or settle on a rock it creates cracks, resulting in additional ground water coming into the system. This puts additional stress on the sewer plant and does not

allow for additional expansion in the city. More information will be shared with the residents impacted in early 2014.

Our long time dedicated City Administrator, Nancy Carswell, has recently announced she will be retiring in March 2014. We are currently taking applications for her position to ensure a smooth transition.

The City Council, Staff and I wish you all a safe and happy holiday!

As I write this article I get a little nostalgic, knowing that this will be my last article as I am retiring in March. I have had a good 29 years at the city and enjoyed many of the challenges and getting to know so many of the residents and business owners.

On December 10th at 7 p.m. the city council will conduct the Truth and Taxation hearing. The purpose of this hearing to explain the proposed budget and tax levy for the following year. The increase of the proposed tax levy translates to a 1.66% increase. The city's Local Government Aid for 2014 increased \$143,601 which was a great help as we have had little permit fees, and interest is awful. Staff will explain the proposed general fund budget for 2014 and compare the items with current year and also go over the tax levy which is made up of general fund taxes, and a few bond payments.

CROW RIVER FOOD COOP

The Crow River Food Co-op Board voted to dissolve on October 14, 2013. The 152 members received refunds that were 91% of their financial contribution. Even though there is a great need in the area for a grocer we found that this was not the right time for a food co-op. The financial pro forma we had completed by a professional showed that the food co-op would not be feasible. I want to thank the volunteers that worked so hard towards making this a reality. There were just too few workers for such a lofty goal of opening a business and when the financial pro forma came out we knew it was time to STOP. We could have tried to open a smaller store or started a buyers club but that is not what we told our members, so the decision was made to dissolve. The Crow River Food Co-op had 152 members that supported our goal and I want to thank them and all of the volunteers, board members, companies and farmers that supported our efforts. The city plans to continue the search for a grocer in town, which I believe will happen someday.

PARKING

The snow season ordinance is in effect until April and it shall be unlawful for any person to park a vehicle on or within six feet of the roadway between 2am-6am OR after ice accumulation, continuous or intermittent snow fall during which there has been an accumulation of two inches or more of snow on any street until the same has been plowed or removed from the full width of the roadway. On street parking is prohibited from 4am-6am on ALL non-residential streets regardless of snow. At NO TIME shall a vehicle be parked upon ANY street in any one place for more than twelve (12)hours. Please make sure that your guests are aware of these regulations so that they don't end up with a ticket or worse yet, getting towed.

SNOWMOBILES

Persons operating snowmobiles within the city limits **must travel on designated trails**. Snowmobiles are prohibited from any public sidewalk/ trail ways provided for pedestrian travel, on private property without the owner's permission, and all other public property unless designated as the snowmobile trail. So, there is no parking or riding of snowmobiles on the levee or city parks, per Ordinance 208.

SNOW PLOWING



It is unlawful to plow snow onto or across ANY city,

township, county or state road. Doing so is a violation of state statue and you will be fined.

SIDEWALK SNOW REMOVAL

In the interest of public safety, the City of Rockford reminds you of the importance of keeping your walkways

cleared of snow and ice. City Ordinance 901.04 states that all snow and ice must be removed from public sidewalks 24 hours after the snow or other precipitation causing the condition.

The throwing or placing of snow or other material in the streets, sidewalks and other public ways is an ordinance violation.

If you live near a fire hydrant, please keep it clear of snow and ice.

2014 Sewer and Water Project

The city is planning to replace old water and sanitary sewer mains within the city. We have established a Capital Improvement Plan which prioritizes areas where there have been the most problems. The first neighborhood or area is Maplewood Manor north of County Road 33 since there have been so many breaks in the water mains and infiltration shown while televising the sanitary sewer mains. The project will also include the replacement of mains on the north side of State Highway 55 between County Road 50 east to 8020 State Highway 55.

The replacement of these trunk mains and the private water services will be paid by the water and sewer funds. The city is also planning on televising the private sanitary sewer services in this area to make sure that if they are cracked or filled with tree roots that they are replaced at the same time. The city ordinance states that the private sanitary sewer services are the responsibility of the property owner. Therefore, we are getting quotes from the private contractor who will televise all of these private sanitary sewer services and provide the city a record of the condition of each service. The property owners have the option of having their service televised and provide the information to the city.

The replacement of the private sanitary sewer services will be paid by the property owner if they are found to be leaking, cracked and filled with tree roots. The city will notify the property owners and conduct an assessment hearing prior to installing the private sanitary sewer services as the city may choose to assess these costs. Some of the private services are over 100' from the trunk main and could be costly, therefore assessing the costs to the tax roll for 7 to 10 years will allow the cost of the improvement over a period of time.

The city has been researching our water and sewer rates knowing that these improvements must be funded by the revenues received. An 8% increase in the water and sewer rate was established in May this year and additional increases will be taking effect in 2014 that will provided the necessary revenue to maintain the operations.
