City Administrator / Attorney, Dan Madsen; Finance Director, Jennifer Swendsen; Darcy Desense of the Public Works Department; City Engineer, Steve Hegland; Deputy Ryan of the Wright County Sheriff's Department; Deputy Magnussen and Sheriff Hutchinson of the Hennepin County Sheriff's Department; Bryan, Laura, Danny and Maggie Franklin, residents; and Aaron Abed and Parker Abed, residents, were also in attendance.

A motion was made by Martinson, and seconded by Seymour, to approve the Consent Agenda Items 3A through 3C as listed and set the Agenda for the Council Meeting:

Deputy Ryan, Wright County Sheriff

Deputy Ryan provided a general update regarding traffic stops and law enforcement activity in the City. No formal action was taken, as this matter was set on for discussion purposes only.

New Business: 2020 Volunteer of the Year, Laura Franklin

Administrator / Attorney Madsen shared that each year, the City of Rockford asks it's residents, businesses and members of the community to nominate a person or group that has evidenced dedication, support and volunteerism in our shared community. People submitting nominations are asked to submit a Nomination Form explaining why they believe their nominee is deserving of the award.

This year, the City Council selected Laura Franklin as the 2020 Volunteer of the Year. Ms. Franklin is being honored for her extensive volunteerism in our Community, including her service on the Rockford Education Foundation, her role as President of the Rockford Greenfield Chamber of Commerce, and her service on the 1,000 Hearts Steering Committee supporting the Crow River Serve Day. Ms. Franklin also supports the Rockford Area Girl Scouts. No formal action was taken, as this matter was set on for informational purposes only.

New Business: Sheriff Dave Hutchinson

Hennepin County Sheriff, Dave Hutchinson, discussed the state of law enforcement in Hennepin County with the City Council. The discussion included updates on training facilities, programs and practices to adapt to societal changes and shifts in demographics. New Business: Parker Abed, Eagle Scout Project

New Business: First Quarter Financial Report

Finance Director, Jennifer Swendsen, walked the Council and Staff through the revenues and expenditures of the General Fund, Fire Department, Water Utility and Wastewater Utility. Charts and graphs were discussed that showed the financial picture of the City, and the Council and Staff discussed the strong financial position of the City Budgets. No formal action was taken, as this matter was set on for informational purposes only.

New Business: Transfer of Toro Sweeper and 1981 Fire Truck to Auction

Administrator / Attorney Madsen explained that the City had two pieces of equipment that had not been used in several years that should be transferred to auction and sold. Members of Staff and the Council discussed and reviewed the 1981 Fire Truck and Toro Sweeper, acknowledging that only the tank part of the truck may have some use and would be looked at by the Fire Chief, Ben Sanderson. After additional discussion and review, Motion was made by Seymour, and seconded by Willenbring, to transfer the equipment to auction for sale.

Motion Carried: Voting in favor; Hafften, Martinson, Buoy, Seymour and Willenbring.

Members of the Staff and Council then presented general updates including the Memorial Day Service / Ceremony on May 31st, Movie in the Park being scheduled for June 4th and other updates of general interest.

Motion was then made by Seymour, and seconded by Willenbring, to adjourn the meeting.
