Notice is hereby given pursuant to Minn. Stat. §§ 429.011 to 429.111 that the Rockford City Council will hold a public hearing at 6:00 p.m. or as soon thereafter on Tuesday, February 12, 2019 at the Rockford City Hall, located at 6031 Main Street, to consider the proposed mill and overlay improvements on the following roadways: Woodhill Drive, Woodhill Court, Bluff Road, Cherry Lane, Woodhill Lane, Autumn Oaks Drive, Kettenacker Drive, Hickory Court, Autumn Oaks Circle, Basswood Circle.

The improvements include milling the top layer of the bituminous asphalt and placing a new surface overlay of bituminous asphalt. Select locations of roadway will include full pavement removal and replacement. Spot curb and gutter replacement and adjusting of stormwater structures will be included to maintain stormwater drainage in select areas. The estimated cost of such improvement is \$483,438.39 with the estimated costs being assessed to affected property owners of \$145,031.52. This assessed amount will be divided among the benefitted properties and will be made payable over a term of years.

The purpose of the improvement hearing is to allow affected property owners to review and comment on the nature and merits of undertaking the improvement project. Adoption by the Council of the proposed improvement may be taken at the hearing.
